■ Commercial Law

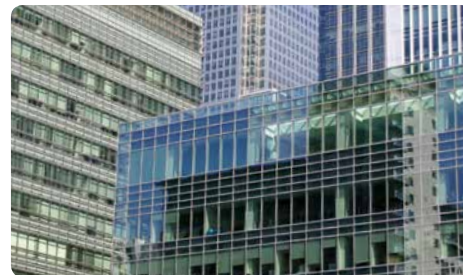
